# SUPPORTED CHILD DEVELOPMENT



## PROGRAM INFORMATION

The Supported Child Development (SCD) Program provides support for children with identifiable diverse abilities to optimally participate in positive inclusive childcare environments during their critical developmental years. This is achieved through direct support to the child within a family's childcare settings of choice, increasing community awareness and capacity to assist in the support and management of children with additional needs in any area of development, free of charge.

## THE SERVICES WE PROVIDE

- Support for children with identifiable diverse abilities within a family's childcare setting of choice to actively participate to their optimal level.
- Support for childcare settings to ensure children with diverse abilities are welcomed, supported, valued and included in daily activities.
- Increasing awareness of available supports and services that assist children with additional needs within community and childcare settings.
- Enhancing community capacity to assist and support in the management and inclusion of children with diverse abilities within community.

## HOW TO ACCESS OUR SERVICES

- Referrals can be made by parents, guardians, care-givers, by community partners with client consent by contacting our office & filling out [a request for service form](#).
- Referrals may also be made by MCFD where services may be guided by MCFD criteria.

## WHAT TO EXPECT

- Once a referral has been made to the Supported Child Development program, the parent/guardian will be contacted by program staff to complete the intake process and ensure program suitability.
- Staff will work to develop goals for service in collaboration with the client, their family, childcare setting(s) and relevant community partners.
- Weekly or bi-weekly sessions, depending on availability and client need.
- Trauma-informed approach to service care.
- Implementation of service plan to reach identified goals.
- Goals are reviewed and updated as necessary on an ongoing basis, with full file reviews taking place every three months.

## ENDING SERVICES

- Services may be concluded for a variety of reasons, which include but are not limited to, client goal completion, MCFD no longer requires client attendance, client needs are no longer a good fit for the program or is no longer interested in services offered through this program.
